In view of the limited prayer sought for by the petitioner, this Court without expressing any opinion on the merits of the case, directs the petitioner to make a fresh representation to the third respondent. If any such representation is received, the third respondent is directed to consider the same and pass orders on merits and in accordance with law as expeditiously as possible.
