PRAYER IN CRL A(MD)No.380 of 2020:

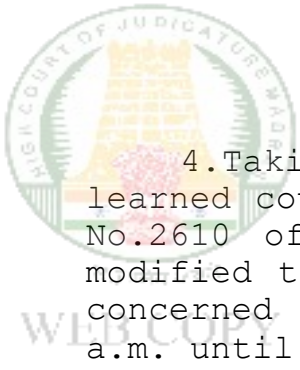
