This petition has been filed to relax the condition imposed against the petitioner in Crl.O.P.(MD)No.5338 of 2021, dated 23.04.2021.

2. The learned counsel for the petitioner would submit that the petitioner was granted anticipatory bail by this Court on 23.04.2021, but, the order copy was received only on 13.05.2021. Since the petitioner had some health issue, she was not able to produce the surety before the concerned Court in time. Hence, she filed a petition for extension of time and the same was allowed on 29.06.2021. Thereafter, the petitioner is complying with the condition from 16.07.2021, without fail.

3. According to the learned Government Advocate (Crl.Side), the petitioner is complying with the condition imposed by this Court regularly from 16.07.2021.



4. Since the petitioner is complying with the condition from 16.07.2021, the condition imposed on the petitioner is fully relaxed.

5. The petition is ordered accordingly.
