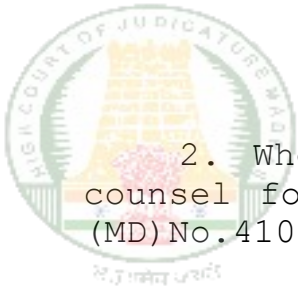
Prayer in WP(MD). 4104/ 2020 :
