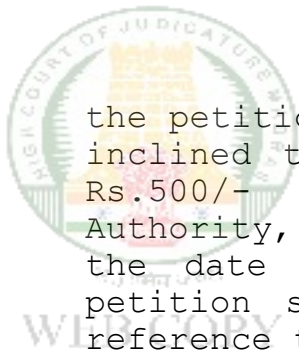
PRAYER IN CRP(MD)SR.No.16307 of 2018:
