Prayer in CRL OP(MD) . 7937/ 2021 :

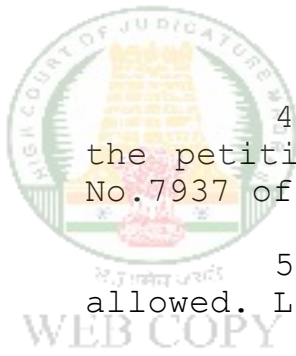
