ORDER

This petition has been filed seeking a direction to the the respondent to file final report in Crime No.52 of 2021 dated 22.02.2021 on the file of the respondent police and proceed with same as per law within the time stipulated by this Court.

2. The petitioner is the defacto complainant. Based upon his complaint, a case in Crime No.52 of 2021 has been registered for the offences punishable under Sections 147, 148, 448, 324, 379, 506(ii) and 109 IPC and Section 3 of TNPPDDL Act, 1992. The learned counsel for the petitioner submits that even after lapse of seven months, there is no progress in the investigation. Hence, this petition.

3. The learned Additional Public Prosecutor would submit that investigation has been undertaken and they will complete the investigation within a period of three months and will file a final report before the concerned court.

4. Considering the request made by the learned Additional Public Prosecutor, there shall be a direction to the respondent to complete the investigation and file a find report within a period of 3 months from the date of receipt of a copy of this order. After filing final report before the concerned court, compliance report shall be sent to the Registry.



5. With the above direction, this petition is disposed of.
