Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a WRIT OF CERTIORARIFIED MANDAMUS calling for the records pertaining to the proceedings of the 2nd respondent in Na.Ka.4245/2012 Nu.Ku.(5) dated 12.07.2012 and quash the same as illegal and consequently direct the Respondents to return the petitioners audit restricted amount of Rs.2,19,161.25 which was paid by the petitioner on 08.03.2014 through Cash/Society receipt voucher by considering the notification issued by the Co-operative Audit Department in Na.Ka.2517/09/Tha.Sa1(2) dated 29.01.2010.
