PRAYER IN CRL.R.C. (MD) SR.No.20640 of 2021 :

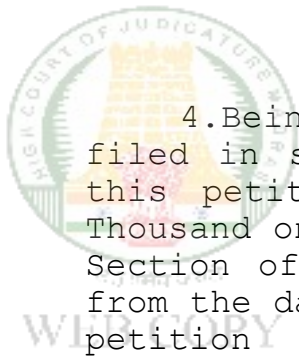
