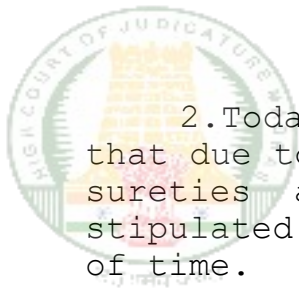
Prayer in CRL OP(MD). No.9058 of 2021 :-
