PRAYER : Petition is filed under Article 226 of the Constitution of India praying for the issue of a Writ of Habeas Corpus, directing the respondents 1 to 2 to produce the person or body of the petitioner's wife Kartheeswari, aged about 26 years and his son Kavinesan aged about one year before this court and set them at liberty.

O R D E R

(Order of the Court was made by V.BHARATHIDASAN, J.)

Alleging that the petitioner's wife, by name, Kartheeswari, aged about 26 years and his son Kavinesan, aged about 1 year, found missing, the petitioner has filed a complaint before the 2nd respondent Police. Since no action has been taken, the present Habeas Corpus Petition has been filed.

2. Today, when the matter is taken up for hearing, Mr.S.Ravi, the learned Additional Public Prosecutor appearing for the State, on instructions, submitted that the detenues have been secured by the 2nd respondent Police, produced before the learned Judicial



Magistrate No.2, Sivakasi and they were permitted to go with the mother of the detainee.

3. Considering the above circumstances, that the detainees have been secured and produced before the concerned Court and they have gone with the mother of the detainee Kartheswari, no further adjudication is required. Hence, this Habeas Corpus Petition is closed.
