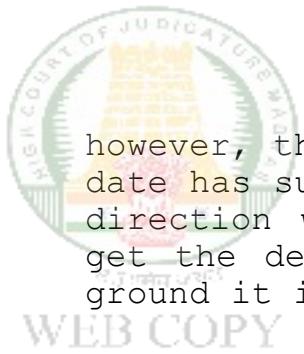

This petition has been filed seeking a direction to the respondents 1 to 3 to provide police protection on the basis of the representation dated 05.08.2021.

On the previous occasion on 22.09.2021, the learned Additional Public Prosecutor submitted that based upon the representation made by the petitioner, enquiry was undertaken and later, he sent e-mail stating that no further action is required on his representation.
