2.The learned counsel for the petitioner submitted that the petitioner and the fifth respondent are husband and wife, due to matrimonial dispute, they were living separately for several years and the petitioner has filed HMOP No.122 of 2021 before the Principal Sub-Court, Srivilliputtur seeking Divorce and he also filed G.W.O.P.No.53 of 2021 before the very same Court for appointment of guardian to the child.
