PRAYER :-

For the Anticipatory Bail in Crime No.372/2021 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner apprehending arrest at the hands of the respondent police for the offences punishable under Sections 294(b), 324, 307 and 506(ii) of IPC, in Crime No.372 of 2021, seeks anticipatory bail.

3. In view of the submissions made by the learned Government Advocate (Criminal side) that six cases are pending against the petitioner, this Court is not inclined to grant anticipatory bail to the petitioners.

4. Accordingly, this Criminal Original Petition stands dismissed.
