2. When the matter is taken up for hearing, the learned Additional Public Prosecutor would submit that based upon the



complaint given by the sixth respondent herein, enquiry was undertaken in CP No.22881/2021 and during the course of enquiry it was found that it is a civil dispute in respect of which a suit is pending before the Sub Court, Tuticorin in OS No.81 of 2020 and so the petition is closed. Similarly, the complaint given by the 6th respondent before the District Crime Branch was also enquired and it came to be closed in CP No.26751/2021 on 02.08.2021.

3. Since the complaint given by the sixth respondent came to be closed, nothing survives for further consideration or direction.

4. Recording the submission of the learned Additional Public Prosecutor, this petition is disposed of as infructuous
