ORDER

This petition has been filed seeking a direction to the first respondent to depute a special investigation officer to investigate the case in Crime no.43 of 2021, on the file of the second respondent police.

2.The case of the petitioner is that her husband died in a road accident which occurred on 10.02.2021. A case was registered on 11.02.2021 in Crime No.43 of 2021 for the offences punishable under Sections 279 and 337 IPC. The grievance of the petitioner is that even after identification of the accused person, no investigation has been taken on this aspect. Hence, this petition.

3.The learned Additional Public Prosecutor would submit that based on the complaint given by the petitioner, case has been registered and 7 witnesses have been examined so far. Now only, the petitioner identified the accused person.

record the further statement of the petitioner and undertake investigation on the basis of the information furnished by the petitioner. In the facts and circumstances of the case, forming of special team does not require.
