Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the 4th respondent herein to grant license/permission for erection of the cell phone tower based on the petitioner's application dated 20.07.2021, within a week and further directing the Respondents 1 to 3 herein to provide the effective police protection to the petitioner Company to erect the cell phone transmission tower at Survey No.301/1, Plot No.40, Sriram Nagar, Appaneri Village, Appaneri Panchayat Limit, Kurvikulam Union, Thoothukudi District and pass such others as this Hon'ble High Court may deem fit and proper in the circumstances of the case and thus render justice.

ORDER

The petitioner seeks a direction to the fourth respondent
<https://hservices.ecourts.gov.in/hservices/> to grant license/permission for the erection of a mobile phone
tower on the basis of the petitioner's application dated



20.07.2021. The petitioner states that it is an internet service provider which is engaged in the business of providing broadband internet services and other allied services on a pan India basis.

2. The petitioner states that the authority to grant a right of way permission in respect of Overground Telecom Infrastructure (Towers) is vested in the District Collector in terms of the Indian Telegraph Right of Way Rules, 2016. In spite of submitting multiple requests seeking such permission, including by the recent application, the petitioner states that such permission has not been granted. In addition, the petitioner has requested for police protection for the erection of such mobile phone transmission tower.

3. Mr.R.Baskaran, learned counsel for the State, accepts notice on behalf of all the respondents. He submits that the District Collector has been entrusted with the task of granting or denying right of way permission and that the petitioner is not entitled to a positive direction with regard to the grant of such permission.

4. As correctly pointed out by learned counsel for the State, the District Collector has been vested with the authority to decide an application for the grant of right of way. Needless to say, such discretion should be exercised reasonably by citing germane reasons especially in case permission is refused. In any case, a positive direction cannot be granted for the issuance of such permission. However, the petitioner is entitled to the expeditious disposal of its application. As regards police protection, unless permission to erect the mobile phone tower is granted, there is no question of granting police protection.

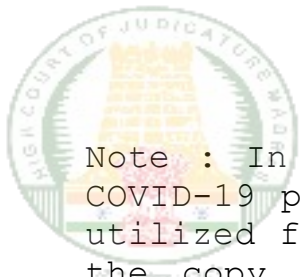
5. Accordingly, without going into the merits of the matter, the fourth respondent herein is directed to consider the petitioner's application for permission to erect the mobile phone tower and dispose of the same by a reasoned order in accordance with law within a period of thirty (30) days after providing a reasonable opportunity to the petitioner, the relevant landlord, and any other person who may be affected by such erection.

6. W.P(MD).No.15027 of 2021 is disposed of on these terms without any order as to costs.
