2.. Hence, the Contempt Petition is closed with liberty to the petitioner to reopen after the disposal of Writ Appeal. No costs.

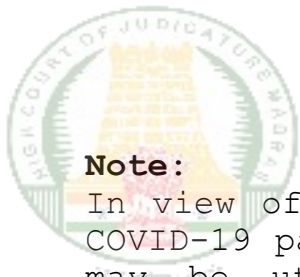
