PRAYER :-

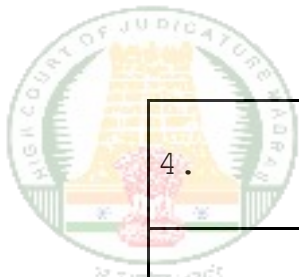
For Anticipatory Bail in Crime No.786 of 2021 on the file of the respondent Police.

ORDER : The Court made the following order :

The petitioner apprehending arrest for the offence under Sections 20(b) (ii) (B), 25 and 29(1) of the NDPS Act, 1985 in Crime No.786 of 2021 seeks anticipatory bail.

2.When the matter is taken up for hearing the learned Additional Public Prosecutor appearing for the respondent submitted that the petitioner has involved in several other cases, of which, four are similar in nature. The details are as follows:
