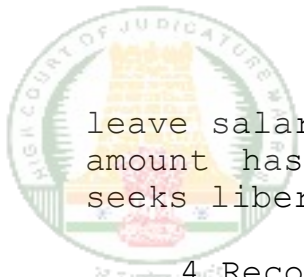

2.The learned counsel appearing for the contemnors would state that the order passed by this Court in W.P(MD).No. 132 of 2020 dated 06.01.2020 has been complied with.

3.Per contra, the learned counsel for the petitioner would submit that the petitioner claimed a sum of Rs.1,44,758/- towards



leave salary along with interest at 18% per annum and the said claim amount has not been fully settled by the respondents. Hence, he seeks liberty to work out his remedy before the appropriate forum.

4. Recording the above submission, the Contempt Petition stands closed. The petitioner is at liberty to work out his remedy before the appropriate forum in the manner known to law.
