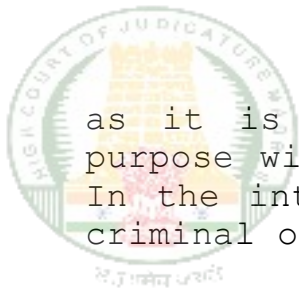

### O R D E R

This criminal original petition has been filed for quashing the impugned FIR in Crime No.733 of 2012 registered on the file of the first respondent.

The petitioner and the second respondent have got married to each other in the year 2012 itself. Three children namely, Yuvaraj, Suchitrasri and Sadhana were born through the wedlock. All the children are present before this Court. When the petitioner and the second respondent were united and are leading a peaceful matrimonial life



as it is evident from the giving birth to three children, no purpose will be served in keeping the impugned prosecution alive. In the interest of justice, the impugned FIR is quashed and the criminal original petition is allowed.
