O R D E R

This petition has been filed to direct the Special Court, PCR Act Cases, Tuticorin to consider the bail application on their surrender on the same day, if any petition filed by the petitioners in Crime No.156 of 2021 on the file of second respondent.

2. The petitioners are the accused in Crime No.156 of 2021, on the file of the second respondent for the offences punishable under Sections 147, 294(b), 323 of IPC, r/w Sections 3(1)(r), 3(1)(s) and 3(1)(f) of SC/ST (Prevention of Atrocities) Amendment Act 2015.

3. Mr.R.M.Anbunithi, learned Additional Public Prosecutor who accepts notice for the respondents 1 and 2 would submit that no previous case is pending against the petitioners and the injured was also discharged from the Hospital.



4. Considering the facts and circumstances of the case and also taking into consideration the submission of the learned Additional Public Prosecutor, this Court is inclined **to allow the petition** as per the following conditions:-

1)The petitioners shall appear before the learned Special Court, PCR Act Cases, Tuticorin, within a period of 15 days from the date of receipt of a copy of this order.

2)On such surrender along with notice served to the defacto complainant, the concerned Judge shall consider the bail application filed by the petitioners and pass orders on merits on the same day of their surrender, after hearing the defacto complainant by complying with Section 15(5) of the Act.

5. Accordingly, this Criminal Original Petition is allowed.
