PRAYER :-

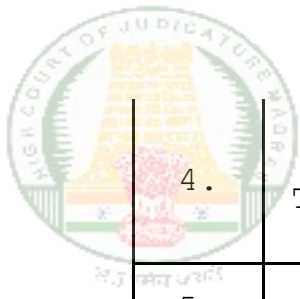
For Anticipatory Bail in Crime No.344 of 2021 on the file

ORDER : The Court made the following order :

The petitioner apprehending arrest for the offence under
Sections 8(c) and 20(b) (ii)(C) of the NDPS Act, 1985 in Crime
No.344 of 2021 seeks anticipatory bail.

2.When the matter is taken up for hearing, the learned
Additional Public Prosecutor appearing for the respondent submitted
that the petitioner has involved in several other cases, of which,
three are similar in nature. The details are as

3.Considering the antecedents of the petitioner that he is involved in several other cases, of which three cases are similar in nature and also considering the seriousness of the offence in the present case, this Court is not inclined to grant anticipatory bail to the petitioner. Accordingly, this petition stands dismissed.
