Contending that this undertaking given before this Court was not complied with, this contempt petition came to be filed.

3. When the matter was taken up for hearing, the learned Additional Government Pleader on instructions stated that the process has already been initiated and that necessary correction will be made within a period of eight weeks from today.

3. Recording the said submission, this contempt petition stands closed.
