4. Since the petitioner is complying with the condition without fail, the condition is fully relaxed.

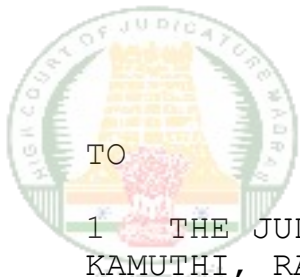
5.The petition is ordered accordingly.
