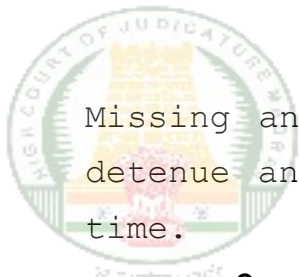

Dinesh Babu, learned Additional Public Prosecutor, on instructions, would state that the detenu's husband Masilamani gave a complaint for missing of the detenu Rebika Sharan, for which, Sevvapettai Police registered a case in Crime No. 2130 of 2020 on 19.09.2020 under Woman Missing. It is further stated that the third respondent's father lodged a complaint with the second respondent Police for missing of the third respondent, for which a case in Crime No. 523 of 2020 has been registered on 02.10.2020 under Man



Missing and the Police are effectively taking steps to secure the detainee and the learned Additional Public Prosecutor seeks further time.
