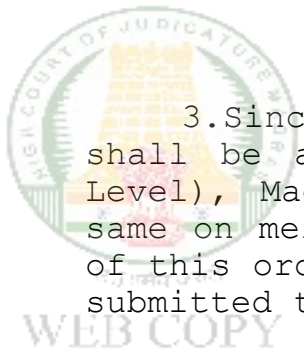

ORDER

This Petition is filed to direct the Learned Fast Track Court No. I (Magisterial level), Madurai in S.T.C.No. 336 of 2018 to expedite the trial within stipulated time by this Court.

2.The case of the petitioner is that he is complainant in the above said matter, which was filed for the offences punishable under Sections 138 & 142 of Negotiable Instruments Act. It was taken on file in STC No.336 of 2018 by the learned Fast Track Court No.I, (Magisterial Level),Madurai. On the side of the complainant, evidence was over and now it is pending for accused side defence evidence, which is clear from the B Diary extract. Since the petitioner is a senior citizen,he seeks speedy disposal of the case.
