Prayer in WP(MD) . 2917/ 2020 :

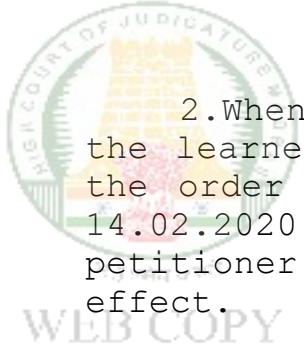
