PETITION FOR BAIL Under Sec.439 of Cr.P.C.

PRAYER :-

For Bail in Crime No.598 of 2021 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioners, who were arrested on 05.08.2021 for the offences punishable under Section 25(1-A) of Arms Act, in Crime No.598 of 2021 on the file of the respondent police, seeks bail.

2.The case of the prosecution is that on 04.08.2021, when the respondent/complainant was on vehicle check-up, they intercepted a Car bearing Reg.No.TN-42-AH-4921 and found that the petitioners and others are in possession of 2 Nos.of swords. On enquiry, the respondent police came to know that the petitioners intended to commit murder of one Manickavasagam.

3.The learned counsel for the petitioners would submit that the petitioners are innocent persons, they have not committed any offence as alleged by the prosecution but a false case has been foisted against them. He would further submit that only on assumption, the petitioners have been arrested. The first petitioner



and Science, Coimbatore and the second petitioner is the acting driver of the said vehicle and they are not having any bad antecedents. Hence, he prayed for grant of bail.

4.The learned Government Advocate(Crl.Side) would submit that the petitioners are not having any bad antecedents.

5.Taking into consideration of the facts and circumstances of the case, the fact that the petitioners have not involved in any other offence and also the period of incarceration, this Court is inclined to grant bail to the petitioners.

6.Accordingly, this Criminal Original Petition is allowed and the petitioners are ordered to be released on bail on their executing a bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate, Pattukkottai and on further conditions that:

[a] the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhaar card or bank pass book to ensure their identity.

[b] the petitioners shall report before the respondent police daily **at 10.30 a.m.** until further orders.

[c] the petitioners shall not abscond either during investigation or trial.

[d] the petitioners shall not tamper with evidence or witness either during investigation or trial.

[e]On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]**.

[f] If the accused thereafter abscond a fresh FIR can be registered under Section 229A IPC.
