When the Contempt Petition is taken up for hearing, the learned Counsel for the petitioner stated that the petitioner lost her life in a road accident.

2.This Contempt Petition is filed alleging wilful disobedience of the order passed by this Court in a Writ Petition preferred by the petitioner in W.P.(MD)No.8944 of 2017. This Court by order, dated 05.03.2021, disposed of the Writ Petition with a direction to the second respondent therein, to consider the petitioner's representation, dated 26.04.2017, in the light of G.O.Ms.No.256, dated 19.04.2017, and to pass appropriate orders within the time stipulated by this Court. It is seen that the petitioner's representation was to transfer her to her native place.
