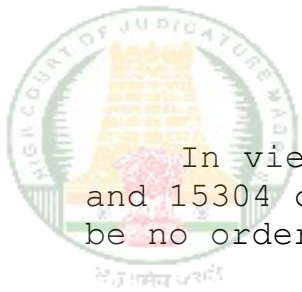
Prayer in WP(MD). 14419/ 2021 :
