2. The petitioners are the accused Nos.1 to 5 in Crime No.85 of 2021, on the file of the second respondent for the offences

punishable under Sections 147, 294(b), 323, 341, 506(ii) of IPC r/w. 3(1)(r), 3(1)(s) of SC/ST (POA) Act.

3. Mr.R.M.Anbunithi, learned Additional Public Prosecutor who accepts notice for the respondents 1 and 2 would submit that the injured has been discharged from the Hospital.

4. Considering the facts and circumstances of the case and also taking into consideration the submission of the learned Additional Public Prosecutor, this Court is inclined **to allow the petition** as per the following conditions:-

1)The petitioner shall appear before the learned District Judge, Sivagangai (Special Judge for PCR Cases), Sivagangai District, within a period of 15 days from the date of receipt of a copy of this order.

2)On such surrender along with notice served to the defacto complainant, the concerned Judge shall consider the bail application filed by the petitioner and pass orders on merits on the same day of their surrender, after hearing the defacto complainant by complying with Section 15(5) of the Act.

5. Accordingly, this Criminal Original Petition is allowed.

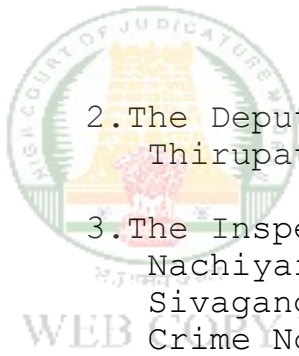
