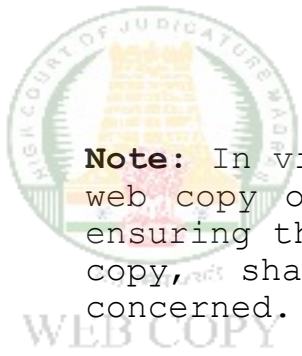
This petition has been filed to extend the time to comply with the condition imposed in Crl.O.P.(MD)No.7306 of 2021 dated 08.06.2021.
