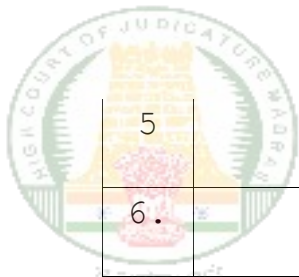
For Anticipatory bail in Crime No.162 of 2021 on the file of the Respondent police.

ORDER : The Court made the following order :-

The petitioner/Sole accused, apprehending arrest at the hands of the respondent police for the alleged offence punishable under Section 341, 294(b) and 506(2) IPC in Crime No.162 of 2021, seeks anticipatory bail.
