PRAYER : Petition is filed under Article 226 of the Constitution of India praying for the issue of a Writ of Habeas Corpus calling for the entire records connected with the detention order of the second respondent in Detention Order No.67 of 2020, dated 20.10.2020 and to quash the same and to direct the respondents to produce the body or person of the detenu by name ,Krishnamoorthi, son of Kandhasamy,



aged about 28 years, now detained as 'Drug Offender' in Madurai Central Prison before this Court and set him at liberty forthwith. .

O R D E R

(Order of the Court was made by K.KALYANASUNDARAM, J.)

This habeas corpus petition has been filed by the detenu, namely, Krishnamoorthi, son of Kandhasamy, aged about 28 years, challenging the detention order in Detention Order No.67 of 2020, dated 20.10.2020, passed by the second respondent, branding him as "Drug Offender" as contemplated under Section 2(e) of Tamil Nadu Act 14 of 1982.

2. Mr.R.Alagumani, learned counsel for the petitioner, would argue that even though the petitioner has raised several grounds, he has confined his arguments only to the delay in disposal of the petitioner's representation. It is submitted by the learned counsel for the petitioner that the procedural safeguards guaranteed under Articles 21 and 22 of the Constitution of India have not been followed in this case and there is unexplained and inordinate delay in disposal of the petitioner's representation, which would vitiate the impugned order of detention.

3. Mr.S.Ravi, learned Standing Counsel for the State, on instructions, submitted that after satisfying with the materials placed by the Sponsoring Authority, the Detaining Authority has passed the detention order and there is no illegality or infirmity in the detention order. It is also stated that even if there is any delay in disposal of the representation, it has not caused any prejudice to the rights of the detenu and hence, prayed for dismissal of the habeas corpus petition.

4. Heard both sides and perused the materials available on record.

5. In the instant case, the pro-forma furnished by the learned Standing Counsel for the State would indicate that as against the impugned detention order, the petitioner made a representation to the first respondent on 5.11.2020 and it was received on 10.11.2020. Remarks were called for on the same day i.e. 10.11.2020 and it was received on 21.11.2020. The Deputy Secretary dealt with the matter on 23.11.2020. The concerned Minister dealt with the matter on 24.11.2020 and the representation came to be rejected on 27.12.2020. It is seen that in between 24.11.2020 and 27.12.2020, there was a delay of 32 days, after excluding the Government Holidays of 8 days, there was a delay of 24



days in considering the petitioner's representation.

6. At this juncture, it is useful to refer the decision of the Honourable Apex Court in the case of **Rajammal vs. State of Tamil Nadu and another**, reported in **1999 (1) SCC 417**, wherein, the Apex Court has observed and held that it is for the Authority concerned to explain the delay, if any, in disposal of the representation and if any delay was caused on account of nay indifference or lapse in considering the representation, such delay will adversely affect further detention of the prisoner.

7. In the case on hand, as stated supra, the delay of 24 days in considering the representation of the petitioner remains unexplained by the respondents. Hence, in our considered view, the detention order is liable to be set aside solely on the ground of delay by following the decision of the Honourable Apex Court referred supra.

8. In fine, the Habeas Corpus Petition is allowed. The detention order in Detention Order No.67 of 2020, dated 20.10.2020 passed by the second respondent, is set aside. Consequently, the detenu, namely, Krishnamoorthi, son of Kandhasamy, aged about 28 years, who is now detained at Central Prison, Madurai is directed to be released forthwith unless his presence or custody or detention is required in connection with any other case.

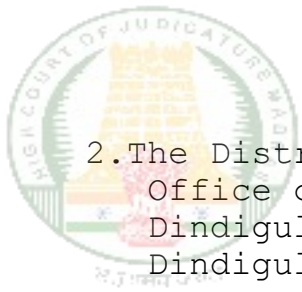
