PRAYER :-

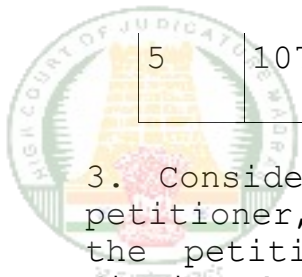
For Anticipatory bail in Crime No. 68 of 2021 on the file of
