PRAYER :-

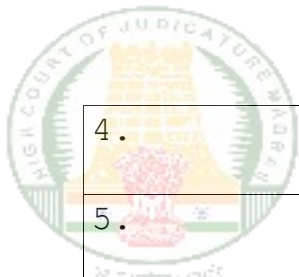
C-33AB. For Anticipatory Bail in Crime No. 122 of 2020 on the file of the respondent Police.

ORDER : The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offence punishable under Sections 269 and 379 of IPC and Section 21(1) of Mines & Minerals (Development & Regulation) Act, 1957, in Crime No.122 of 2020, seeks anticipatory bail.
