PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No.246 of 2021 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offence punishable under Sections 379 of I.P.C. r/w 4(1)(1A), 21(1) of Mines and Minerals (Development and Regulation) Act, 1957, in Crime No.246 of 2021, seeks anticipatory bail.

2.The case of the prosecution is that the petitioner along with other accused was found in possession of 2½ units of river sand illegally. Hence, the present case has been registered.



3.The petitioner is involved in seven other cases. The details of the pending cases are as follows:-
