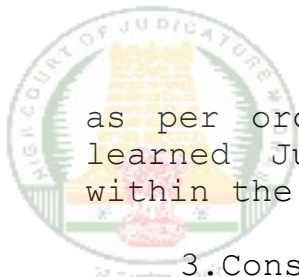
PRAYER IN CRL MP(MD)NO. 9462 OF 2021 in CRL OP(MD)No.6519 OF 2021:
