PRAYER :-

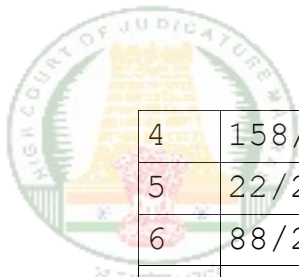
For Anticipatory Bail in Crime No.63 of 2021 on the file of the Respondent Police.
