PRAYER :-

For Anticipatory Bail in Crime No.969 of 2021 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offence punishable under Section 379 of IPC r/w Section 21(1) & 21(2) of Mines and Minerals (Development and Regulation) Act, 1957 in Crime No.969 of 2021, seeks anticipatory bail.
