PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a writ of habeas corpus calling for the records pertaining to the impugned detention order passed by the 2nd respondent made in his proceedings in P.D.No.75/2020 dated 28.10.2020 in detaining the detainee under Section 2(f) of the Tamil Nadu Act 14 of 1982 as a Goonda and quash the same and direct the respondents to produce the detainee namely, Mahesh S/o Kaliyaperumal, male, aged about 42 years, who is detained in Central Prison, Tiruchirappalli before this Court and set him at liberty.

When the matter is taken up for hearing today, the learned counsel for the petitioner as well as the learned Additional Public Prosecutor for the respondents, by producing a copy of G.O.Rt.No.239, Home, Prohibition & Excise (XV) Department, dated 11.01.2021, would state that the impugned detention order has been revoked by the Government.

3. Recording the above submissions, the habeas corpus petition is closed.
