Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records on the file of the 3rd respondent in connection with the order passed by him in Ref.No. 52374/E5/1/2013 dated 26.07.2013 and quash the same to the extent of excluding the degrees, diplomas and post graduate degrees granted by the 4th Respondent University for consideration of the petitioners for appointment/promotion to the post of Non Medical Assistant to the Professor of Bio Chemistry or Bio Chemist or Librarian in case of possession of B.L.I.S., from the cadre of Lab Supervisor/Non Medical Demonstrator and direct the respondents to include the Vinayaka Missions University in the List of Universities given under Schedule II Rule 19 of the Tamil Nadu State and subordinate Service Rules immediately and consequently consider the petitioners for promotion/appointment to the post of Non Medical Assistant to the Professor of Bio Chemistry (or) Bio-Chemist (or) Librarian Grade I as for as the 3rd petitioner is concerned for the year 2012-2013 atleast and promote them to the said post.
