This petition has been filed to relax the condition imposed against the petitioners in Crl.O.P.(MD)No.10444 of 2021, dated 11.08.2021.

2.The learned counsel for the petitioners would submit that the petitioners 1 to 3 & 5 are complying with the condition regularly and the 4th petitioner has not complied with the condition regularly.



3. The learned Government Advocate (Crl. Side) submits that while the petitioners 1 to 3 & 5 are complying with the conditions regularly, the fourth petitioner has not complied with the condition regularly.

4. Since the petitioners 1 to 3 & 5 are complying with the condition regularly, without fail, the condition imposed on the petitioners 1 to 3 & 5 alone is fully relaxed.

5. Insofar as, the fourth petitioner is concerned, this petition is dismissed with liberty to file a fresh application.
