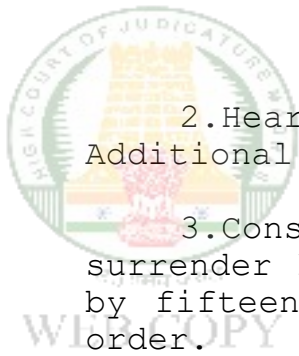
Prayer in CRL OP(MD) . 8813/ 2021 :
