ORDER

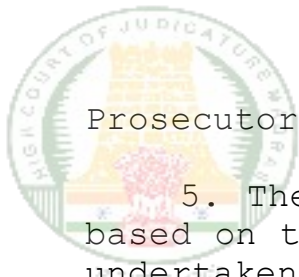
This Criminal Original Petition has been filed to direct the first respondent not to harass the petitioners and her family members without any legally sustainable complaint.
