Writ Petition is filed under Article 226 of the Constitution of India, praying this Court directing the respondent to provide ENHANCED COMPENSATION for the acquisition of petitioners land admeasuring 8440 sq.mtr. situate in karaikudi-Ramanathapuram National Highway - Thennevayal village - Survey No.31/1, 31/3A1A, 31/4C2 of Sivagangai district, by following the provisions of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and at par with the similarly placed persons in Kannankottai Village and as per Order in WP(MD) No.21735 of 2017 dt 25/01/2018 by considering petitioners representation dated 28/12/2019

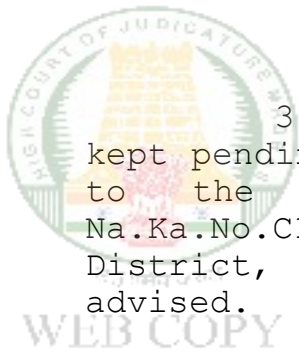

ORDER
