The petitioner has challenged an order appointing an Urus Committee to conduct a festival from 08.09.2021 to 07.10.2021. After the writ petition was filed, a communication dated 11.09.2021 was issued by the Revenue Divisional Officer, Aranthangi to the District Collector, Pudukottai. In terms thereof, the relevant festival was



cancelled. Therefore, nothing survives of the present writ petition, which has been rendered infructuous by subsequent events.

2. By recording the aforesaid, W.P(MD).No.16429 of 2021 is dismissed as infructuous. However, it will be open to the petitioner to continue to prosecute the petition relating to the extension of tenure of the Administrative Committee. There will be no order as to costs. Consequently, connected W.M.P(MD).No.13288 of 2021 is closed.
