Prayer in WP(MD). 13507/ 2013 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorafified Mandamus calling for entire records relating to the impugned proceedings of the 1st respondent in his proceedings in Na.Ka.No.20250/V1/E3/2013, dated 17.7.2013 quash the same as illegal and consequential direction to regularize the services of the petitioners as full time vocational instructor on par with her juniors, by upgrading the petitioner scale pay from consolidated pay to that of vocational instructors Grade II i.e, B.T. Assistant scale pay and pass such other or further orders as this Honble Court may deem fit.

ORDER
