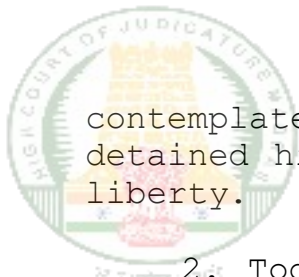
PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a writ of habeas corpus calling for the entire records connected with the detention order passed in M.H.S.Confdl.No.92/2020 dated 06.11.2020 on the file of the second respondent herein and quash the same and direct the respondents to produce the detenu or body of the detenu i.e., the petitioner's husband namely, Jegan, aged about 36 years, S/o Yesuvadiyan now detained at the Central Prison, Palayamkottai before this Court and set him at liberty forthwith.

The petitioner has filed the habeas corpus petition seeking to quash the proceedings of the second respondent in M.H.S.No.92/2020 dated 06.11.2020, branding the detenu viz., her husband, Jegan, son of Yesuvadiyan, aged about 36 years, as a "Sand Offender" as



contemplated under Section 2(gg) of Tamil Nadu Act, 14 of 1982, detained him at the Central Prison, Palayamkottai and to set him at liberty.

2. Today, when the matter is taken up for hearing, the learned counsel for the petitioner as well as the learned Additional Public Prosecutor for the respondents, by producing a copy of G.O.Rt.No.222, Home, Prohibition & Excise (XIV) Department, dated 11.01.2021, would state that the impugned detention order has been revoked.

3. Recording the above submissions, the habeas corpus petition is closed.
